2. **William Sieruta, P.E.**, present **71 Cushman Road**, owner **Paul Kosloski**. Received letter from **Steve Ball, HA. ( Health Agent)** dated 10/16/2010. Proposed plan will need a variance of 218-8.5a of the Local Code width of leach field from 12 feet to 20 feet. This plan appears to meet requirements of Title 5 of State Code and Leverett Local Regulations. Received from **William Sieruta, P.E.** formal variance request to the BOH Local Code 218-8.5a dated 10/7/2010. **Zipkowitz** moved to grant a variance (waiver) to BOH regulation 218-8.5a as providing the proposed maximum feasible compliance of the plan dated 10/7/2010. **Fair** seconded. Motion passed. Assigned **DSCP#R2010-10-18a**. **Zipkowitz** signed application. Received from **William Sieruta** check# 8011, dated 10/18/2010 for \$300.00 for DSCP Application for **71 Shutesbury Road**.
3. **William Sieruta, P.E.**, present **60 Hemenway Road**, owner **Barry Black** present. Plan dated 10/16/2010. Received letter from **Steve Ball, HA** dated 10/16/2010 stated that a variance of the Leverett Code 218-8.5a is needed. Assigned **DSCP#R2010-10-18b**. Received from **William Sieruta, P.E.** formal variance request to the BOH Local Code 218-8.5.5a dated 10/16/2010. **Dauchy** moved that the BOH grant a variance requirement for 12' to 20' leaching system repair. **Phillips** seconded. Motion passed. **Dauchy** moved to approve **DSCP#R2010-10-18b** permit for **60 Hemenway Road** based on plan dated 10/16/2010. **Hillman** seconded. Motion passed. Received from **Harijap S. Fuller** check # 2555, dated 10/18/2010 for \$450.00. (\$350.00 DSCP, \$150.00 Soil Evaluation). **Dauchy** signed DSCP Application.
