**Running for Office?*

Elected officials with expiring terms who are running again as well as new candidates for office are asked to submit substantive statements to the *Newsletter* editor at townclerk@leverett.ma.us or leave in Town Clerk box at Town Hall, by **1 March 2014**. Offices up for election are:

Assessors: One three-year term

Board of Health: One three-year term

Library Trustees: Two three-year terms

Constable: One three-year term, one two-year term

Finance Committee: Two three-year terms

Assistant Moderator: One one-year term

Moderator: One three-year term

Planning Board: Two five-year terms

School Committee: One three-year term; two two-year terms

Select Board: One three-year term

Tree Warden: One one-year term

***If you are interested in running for office (and you are) please take a minute to read the short synopsis of each "job." You may find something that suits you.**

Assessors: Includes three elected Assessors and one appointed half-time Administrative Assessor. The primary responsibility is to assure that property assessments are established and maintained in a fair and equitable manner in accordance with state mandates, and to process warrants for real estate, personal property, forestry, and vehicle excise taxes. The office of the *Assessors is the only elected position in town that has state-mandated qualifications that must be achieved within the first term of office*. Qualified individuals can handle razzing about the high taxes in Leverett. **Meetings:** approximately twice per month.

Assistant Moderator: Performs the duties of the Moderator (running town meeting) in his/her absence.

Board of Health: Primary duties relate to the protection of public health, promotion of sanitary living conditions, control of disease, and protection of the environment. The Board of Health oversees soil evaluation and perc tests and approves disposal systems (for new

construction, additions, and repairs or replacements of existing systems), and applies well regulations. **Meetings:** two or more times per month.

Constable: Responsible for posting warrants for town meetings and elections. Constable is present during elections to ensure safety of polling place, to refill the donut plate, and to make the coffee.

Finance Committee: Oversees town spending. Works with Select Board prior to town meeting on budget issues; run the annual budget hearing; approves (or not) expenditures from the reserve account. **Meetings:** Several per year, more during the months of January-March when the next fiscal year budget is being drafted.

Library Trustees: Responsible for overseeing the library and establishing policies and plans to provide services to the community, determine final budget, and conduct public relations. The trustees value individuals who are team players, have a sense of humor, and are avid readers. **Meetings:** once per month (except in July and August).

Planning Board: Writes zoning and subdivision bylaws. Members meet with individuals seeking to build or modify homes or divide land, and help decipher bylaws for the confused. The board is in the process of modifying the subdivision regulations as they relate to developments of 6 or fewer homes and making amendments to the conventional subdivision regulations. **Meetings:** once a month (except in summer).

Select Board: Official governing body of the town charged with setting polices and regulations which are not within the realm of town meeting. Members make appointments to ad hoc boards, committees, and commissions; work directly with police, fire, and highway departments; authorize spending, calls town meetings; set the warrant for Annual Town Meeting, develop town budget in cooperation with Finance Committee. ETC, ETC, ETC. **Meetings:** Second, fourth (and fifth if there is one) Tuesdays of the month.

• **Candidate's statements:** Candidates for elected office **must submit a statement of intent to the Newsletter by 1 March 2014.**

SELECT BOARD

Budget season is in full-swing. Once again, the total budget will probably be uncomfortably close to the levy limit with little to spare to put toward reserve funds, increased staffing for the Fire Dept. (as recommended by the Leverett Fire Study committee), or the OPEB (Other Post Employment Benefits) fund which we have talked about in other reports and town meeting. Every year there is a town-wide budget hearing and we encourage everyone who is interested to come; this is a good chance to get informed for the vote on the budget at the annual town meeting (which is on Sat. May 3rd this year).

Siemens has agreed to replace the new furnaces at Town Hall which were installed a few years ago as part of the ESCO contract to improve energy efficiency. There has not been a problem-free season with these furnaces since they were installed and this year, on New Year's Eve, there was a "melt down" in the 2nd floor furnace leading to a release of carbon monoxide and lots of smoke. John Kuczek and the Leverett Fire Department responded promptly to the smoke alarm and got the situation under control. The furnace was repaired the next day but this was really the last straw for these furnaces. New furnaces (Regal Lowboys) from a different manufacturer (Boyertown Furnace) will be going in soon. Meanwhile John K. installed new smoke/CO monitors throughout the Town Hall and easy-to-read CO detectors in every office and downstairs. The new furnaces will be slightly less energy-efficient than the ones being replaced but presumably they will work.

The Attorney General's Office has promptly approved the zoning bylaw amendment passed at the Dec. 17 (postponed to January 14) Special Town Meeting regarding the placement of solar panels between LES and the Public Safety Complex. The Town is now ready to move ahead on this project. Final contract details are being worked out with The Solar Store of Greenfield. Thanks to everyone for showing up at the special town meeting; although we were concerned that there might not be a quorum it was clearly no problem!

The Affordable Housing Trust has been working to promote a couple of projects in town, one of which will be on the Town Meeting Warrant this May as a CPA proposal from Pioneer Valley Habitat for Humanity to build 2 units on Cave Hill Rd. This is a great opportunity for the Town to partner with this esteemed national organization to help fulfill affordable housing goals. There are more details in this newsletter.

The second project involves the use of the Town's mortgage buy-down program which is part of the *Town of Leverett Strategic Housing Plan*. One requirement for enacting this program is an affordable housing deed rider; although this seems like it should be simple (just use an existing rider) it has involved much back-and-forth between the MA Community Preservation Commission and the DHCD (Dept. of Housing and Community Development). When developing this plan it was decided that we did not want to be part of the state's affordable housing program which requires applicants to have an income of 80% AMI (average median income) for the region and that no particular groups of applicants are shown preference. CPA rules allow affordable housing for applicants at 100% of AMI, which widens the pool; also, by not being part of the state's affordable housing program we can give preference to town employees and residents. We are now close to having the deed-rider approved so we can move forward with the application that we have. The *Town of Leverett Strategic Housing Plan* is on the town's website.

The proposal for a region for the Leverett, Shutesbury, Pelham and Amherst schools that includes preK-12 has gone through some changes. The initial proposal that was voted on by the RSDPB was for a region for Prek-6 and did not involve the current ALPS 7-12 region. As the process went along it became clear that a Prek-12 made more sense from a fiscal and administrative point of view. The procedure for this requires an amendment to the existing regional agreement which is a different process. The RSDPB will be replaced by a Regional Agreement Working Group (RAWG) appointed by the Regional School Committee (RSC). As of this time the RSC has voted to keep the current members of the RSDB as members of RAWG.

From the Leverett School Committee:

The School Committee is in the process of budget planning for Fiscal Year 2015 (July 2014 - June 2015). The school principal, Anne Ross, with the help of the Union 28 central office, has drafted a budget for the school which meets the Select Board's request (informed in turn by Proposition 2 ½ town-wide budgetary constraints) that the overall school budget not rise by more than 2%. The budget is under discussion but is not final as of this writing (early January). It will be discussed with the Select Board within the next few weeks, some adjustments may be made to account for personnel and other changes, and it will be voted on at a subsequent School Committee meeting prior to being presented at Town Meeting in May.

Preparing a budget is a challenge for any department, and there are many components to the school budget. State and federal mandates require that we provide certain services and assessments, and many costs are fixed even though the school population has declined in recent years. Last year's budget was a decline over that of the previous year, primarily because a larger-than-usual grade of students (requiring two classes and two teachers) moved on to the middle school, and three teachers who retired were replaced at a lower pay rate. Prior to last year, the budget had been level-funded for the past five years, requiring cuts in instructional materials, professional development, and other areas. However, the School Committee believes we are still providing an excellent educational experience at LES. Teachers, staff, and administrators are dedicated to providing a rich, intellectually challenging, and warm environment. Students have the opportunity to take part in educational programs that are not traditionally provided at an elementary school, such as the outdoor adventure program, the greenhouse program, and laboratory science outside of the classroom, that enhance learning and make it enjoyable. Our current budget leaves these programs intact.

We are also pleased to announce that Robert Mahler, the current interim superintendent of Union 28, will continue as interim superintendent until July 2015. This will allow the Union to defer hiring a permanent superintendent until Leverett and Shutesbury decide whether to remain within Union 28, or to regionalize with Amherst and Pelham at the elementary level. We have received only positive feedback on Bob's first six months as an interim superintendent and are happy that he will be with us for another 18 months.

Fire Department

Brush burning season started January 15th and will run until April 30th. There are two ways to obtain a burning permit. If you have access to the web, go to www.fcburnpermits.com, and follow the directions, or you can also go to the town website and it will direct you to this address. If you do not have access to the web, call the dispatch center at 625-8200 and they will issue you a permit. Using the web is the best method for obtaining a permit. It is strongly recommended that burning be done early in the season because of the possibility that it will be shut off as it becomes dry and windy. Note: The DEP will not allow open burning if adverse weather conditions are forecast.

Did you know that smoke detectors are only good for 10 years? Even if you push the button and the alarm sounds, it does not mean it still works properly. If yours are ten years or older, replace them. It is a small price to pay for your safety. The same applies for carbon monoxide detectors, except their life span is 7 years. The best way to check the age of a detector is by removing it and looking on the back for the date of manufacture.

If you burn wood, when you empty the wood ashes, they must be placed in a metal bucket with a lid and taken outside, away from your home. The ashes may seem cold, but many times they are not and still give off carbon monoxide as well as smolder, sometimes for days. Once you are sure they are cold through and through, dispose of them.

TOWN STREET LIST/CENSUS

Annual street list/census forms were sent to each household in town in mid-January (they are green). In order to stay on our voting list, make accurate predictions of our school population, and to keep reliable records for our emergency responders, it is important that these forms be returned quickly. Please note that the political party designation next to a name on this form indicates that you are registered, and in which party. This is not an official voter registration form. No additions, deletions or changes will be made to the voting list based on the street list form. If you want to change parties or register to vote, please do so in the Town Clerk's office, or by mail (forms available at Town Hall).

Council on Aging News

FOOT CARE CLINIC: The COA is introducing a foot care clinic to Leverett as requested by some of our seniors. Older people, people with compromised health and people with diabetes and/or neuropathy are at greater risk for infection, skin breakdown, or other complications related to their inability to look closely and critically at their feet. A thorough inspection of the foot, early intervention and good care can ward off painful or potentially life threatening conditions. Kate Clayton-Jones, RN, will be offering half-hour sessions on February 27, April 10, May 22 and June 26. She says, "As a foot care nurse I start off with an assessment and then I take care of the feet. I do a reflexology-guided massage at the end, which my clients say they really enjoy. I also make recommendations and if need be, referrals." Due to uncertainty of how much this service will be used, and limited funds, a suggested amount to cover some or all costs is requested, from \$15-\$25.

CHAIR YOGA: Wednesdays, 10:00, Town Hall. \$5, first class free. Have you tried it yet?

THE CIRCUIT BREAKER TAX CREDIT: Amount #1 - Add up all your income, including social security. Now find 10% of that number. Amount #2 - Figure out what you paid for property taxes last year on your home (not on large pieces of land too). If amount #2 is more than amount #1 and you or your spouse is over 65, you may qualify for the circuit breaker tax credit on your Massachusetts tax return. This refundable credit can be worth up to \$1030 this year (you can receive it even if you do not have any taxes to pay).

FILE OF LIFE: Do you have a File of Life card on your refrigerator? On it, you fill out a mini medical history with an emergency contact and then place it visibly on your fridge. We would like all senior and disabled homes to have one. Pick one up downstairs at town hall.

GOLD CANE: At the end of last year, for the first time in our town's history as far as we can figure, the Boston Post Gold Cane Award was given to a married couple: Paul and Arlene Woodard, who were the oldest man and woman living in Leverett. Sadly, they have both passed away since and we send condolences to their family. They will be missed by many.

Habitat for Humanity/CPA Project

Pioneer Valley Habitat for Humanity (PVHH) has been working closely in partnership with the Leverett Affordable Housing Trust on a Habitat project in Leverett. Last week the Leverett Affordable Housing Trust voted full support of our proposal to the Leverett Community Preservation Committee. We have recently negotiated an option to purchase a parcel of land on Cave Hill Road for the development of two permanently deed-restricted affordable homeownership units and are requesting \$150,000 to help fund the cost of the project.

The total project costs are estimated at \$411,400 which includes land acquisition, site work, construction and soft costs. Each home will have 3 or 4 bedrooms and at least 1.5 baths and will be built for a high level of energy efficiency in order to provide additional affordability for the families who purchase them. PVHH's model for building affordable housing fully engages the community and the eventual homeowners to provide the majority of the labor in the construction of Habitat homes. This volunteer component is unique to

Habitat for Humanity and significantly reduces the cost of construction which is Habitat is able to successfully-complete small scale projects and sell the completed homes at an affordable price. In their 25 year history in the Pioneer Valley, Habitat has built 35 homes in Hampshire and Franklin Counties with significant support from area churches, college students, small businesses, high school students and hundreds of individual volunteers. CPA funds are a vital source of support for small scale projects as there are no state or federal funding sources for projects of this size.

From the Collector's Office:

2014 Motor Vehicle Excise Bills are due by 5pm Tuesday, February 25th. Remember, it is the responsibility of the taxpayer to pay on time, regardless of when or if a bill is received. If you own a car and did not get an excise bill, call the collector's office. If you move, be sure to notify the registry of your new address so your bill can be delivered promptly. **PLEASE DO NOT IGNORE AN EXCISE BILL**; if you don't think you owe it, contact the Assessors' office 548-4945. Late payment can cost an additional \$71 in fees plus interest, and the bill must be paid in full before you can renew your license or registration.

Market value is NOT considered for the purpose of assessing motor vehicle excise tax. It is based on a five-year decreasing percentage (90%, 60%, 40%, 25%, 10%) of the *manufacturer's list price in the year of manufacture* and billed at a statewide rate of \$25 per \$1,000 of valuation. It is assessed for a *calendar year* and paid in advance; so if you don't own the vehicle for the entire year, file an application for abatement with the Assessors' Office. The excise will be adjusted accordingly or, if already paid, a refund issued. If abatement is not granted by the due date, pay the bill in full and, if applicable, a refund will be processed.

Pay online at the link on the Town's homepage Leveret.ma.us. (only .25 for electronic check; variable fees apply for credit card payments). You can also sign up for direct pay, and your account will *automatically* be debited on the due date. If paying by check, please write bill# in memo section. Mail payment to Collector, PO Box 300, or drop off at the Town Hall (there is also a drop-off box at the back entrance). If office is closed, please do not interrupt other Town Hall staff with questions regarding your tax; you can leave your check (or question) in the Collector's mailbox. Office is generally open M TU Wed 2:30 – 9:30pm (weekend hours by appointment; call 548-9666 or email treasurercollector@leverett.ma.us).

COMMUNITY PRESERVATION COMMITTEE

The Community Preservation Committee has funds available for open space preservation, affordable housing, historic preservation, or recreation. Applications for CPC funding this year are:

1. For rehabilitation/repair to the roof and chimney of the Leverett Family Museum (\$17,817 requested from Community Preservation funds);
2. For repairs to gravestones at the Moores Corner Cemetery (\$5,875 requested from Community Preservation funds);
3. For purchase and conservation of approximately 90 acres of land on Cave Hill Road (\$190,000 requested from Community Preservation funds);
4. For replacement of windows at the Leverett Crafts and Arts center (\$44,000 requested from Community Preservation funds);

In addition, Habitat for Humanity has indicated it's intention to apply for funding for 2 affordable homes to be constructed on Cave Hill Rd. See Habitat for Humanity/CPA Housing Project on previous page.

Completed applications will be presented at a public meeting to be held on Wednesday, April 2, 2014 at 7:30 at Town Hall. Please come hear about the proposed projects at the public meeting.

Copies of all applications submitted are available at Town Hall. Any projects recommended to Town Meeting will be voted on at the Annual Town Meeting.

LEVERETT HISTORICAL COMMISSION

"Celebrating the Civil War Era in Leverett"

The Historical Commission is thrilled to report several upcoming events celebrating our rich history:

On Sunday afternoon, March 9, 2-4PM you are invited to join your neighbors at the Leverett Library to hear Frederick (Rick) Schneider, local illustrator, designer, and educator give a **talk and slide show on "American Illustration in the Civil War Era."** We hope the timing will allow parents to bring their children – particularly the LES Sixth Grade who are researching notable Leverett "people/ places/ things" from the Civil War period.

The Leverett Cultural Council has blessed us with a grant to present a **staged reading of "Hallowed Ground," a contemporary play (IRE Best New Play 2002) which looks at issues raised for families in Leverett 150 years ago** of friendship/growth, grief/loss, life/death, peace/war. We will be looking for interested Leverett actors and directors to help put on this performance. If you are interested please call Carole DeSanti at 413-549-2731. LES sixth grade students have visited four local cemeteries to do research on the Leverett citizens who fought in the Civil War. They plan to visit the Town Hall vault, Leverett Family Museum and Moore's Corner School House museums to study objects in those collections from the Civil War era in Leverett.

Improvements at historic sites which have received Community Preservation Commission funding - Silas Ball cleared brush which was encroaching on the outhouse behind the Moore's Corner School House Museum.

LHC voted to support the Leverett Historical Society's application for funding to the Community Preservation Commission to restore broken and fallen stones in the Moore's Corner Cemetery and to begin the process outlined in Lisa Lipshire's 2013 Preservation Report for the Leverett Family Museum, beginning with restoration of the roof and chimney.

Strategic Plan for Leverett Cemeteries - There was consensus on the Commission that it would be useful to survey the cemeteries of Leverett and to set forth a strategic plan for sustainable maintenance of all of them in the future.

Commission members voted to alternate meeting times between weekday evenings @ 7:30PM, Saturday mornings @ 10AM and Friday mornings @ 9:30AM or after 1:30PM. **NEXT MTG. - Saturday, March 1, 10AM Town Hall. All interested friends/neighbors are welcome**

Broadband Committee Report

Our project is moving along with the expected date of completion of December 2014.

To recap what this project is all about, and how we got here . . .

At the Town Meeting in April 2012, a warrant article passed with a 306-33 vote that authorized the Town to borrow 3.6 million dollars to build a fiber broadband network in town. A subsequent debt override vote in June 2012 passed 461-90. The goal of this project is to bring internet and voice services to each home. There is no traditional video service similar to a cable TV offering, although streaming services like Netflix and Hulu will be available. This project will not have any direct effect on cell phone reception in town. No one in town is required to accept either internet or phone services that will be offered by the network; anyone who does want either service will need to pay for it, at a cost to be determined soon.

The committee is in the process of selecting a single provider for the network, and expects to reach an agreement with a provider in the coming months. At that time, we'll announce the costs of the internet and phone services, and plan to have informational meetings in the fall to introduce the provider and its services to Leverett residents.

In September and October, our contractor Millennium Communications/Matrix Design visited most homes in town in order to plan for the construction of the fiber connections to each home. As part of the process, each homeowner must sign off on the plan. The plan is to have the fiber follow the path of the existing utilities (electrical, phone) from the road. If the phone/electrical connections are buried between the road and the home, we will bury the fiber, using any conduit that is available. If the phone/electrical connections are aerial between the road and the home, the fiber connection will also be aerial.

Most home owners have signed the plans, indicating that they agree with the plan to bring the fiber connection to their homes. Personal Property Tax

The Personal Property tax is a relic of the colonial era, when the number of goats, swine and neat cattle (even the language is ancient) owned was a valid measure of a person's wealth. Today it is often a source of confusion and misunderstanding. However, the law is still on the books, and the Assessors are required to collect property data and bill for qualified property.

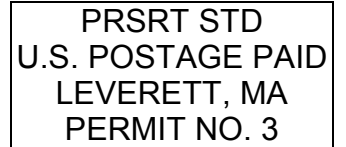
Determining what property is subject to the personal property tax can be confusing. The Massachusetts Department of Revenue defines Personal Property as "...goods, material objects and other things capable of ownership, which are not so firmly attached to, or specially designed for, real estate as to become part of the real estate ..."

Typical items Leverett taxpayers need to report are:

- Merchandise and stock in trade. Goods and wares for sale, whether in a store or any other place for sale, on consignment, or in storage or a warehouse.
- Business and professional office furnishings, fixtures and equipment. Computers and other office equipment if used in a business.
- Machinery, equipment and tools not exempted above. Includes stationary tools such as table saws, etc, heavy machinery, farm machinery and restaurant equipment.
- Medical and dental office equipment; professional libraries.
- Animals (Spot and Fluffy appear to be exempt, while Black Beauty, Bossy, Babe and just about any other creature that might reside in a barn, coop, pen or paddock are taxable).
- Unregistered motor vehicles & trailers (includes tractors, snowmobiles, golf carts and all other kinds and types of unregistered vehicles).
- Household furnishings not situated in the owner's primary residence, i.e. furnishings of summer/second homes. (Please file **Form 2HF**).

Personal property subject to taxation must be reported to the assessors on **State Tax Form 2**, known as the **Form of List**. Forms are mailed to taxpayers who have been subject to the tax in past years, or we believe might have taxable property. Any taxpayer who believes that they are subject to the tax and does not receive a Form 1 should contact the Assessors office for a copy.

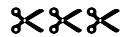
