1.) Hillman moves to approve the minutes from 5/5/08, as amended. Fair seconds, all vote in approval.

- 2.) Received from Alan Weiss, R.S., Title-5 Inspection Report, dated 5/2/08 for **473 Long Plain Road** (Alison Whitlock, owner). Weiss certified that the system "Passes" the inspection criteria. Also received from Alison Whitlock, check #1405, dated 5/6/08, for \$150.00 for the T-5 witness inspection fee.
- 3.) Received from Luis Medina and Margarita DeMedina, check #2947, dated 4/16/09, for \$150.00 for the witness fee for the Title-5 Inspection Report, dated 4/15/08 for **65 Amherst Road** that was previously submitted.
- 4.) Received from Steve Ball, Health Agent, Certificate of Compliance for Peter Heronomous, 146 Still Corner Road, signed by Ball and Installer (L&F Construction), dated 4/10/2008. Alan Weiss had previously submitted his final inspection report (but mistakenly listed the system as "7 Still Corner Road"). The actual address is 5 Still Corner Road, but the property was previously known as Map 8, Lot 146. DSCP# C2006-08-21A.
- Rattlesnake Gutter Road, DSCP# R2008-05-05A. The Board members discussed each item in the review and agreed that additional information needs to be submitted having to do with the monitoring device in the S.A.S., the air pump specifications, the air-line penetration of the septic tank riser, and the Operation and Maintenance particulars. The consensus was that a full Title-5 System Inspection is not needed, but that the tanks, D-box and S.A.S. need to be inspected by the engineer and a statement must be submitted that the failure (or failing) criteria specified in the SludgeHammer Approval Letter has been met. The Board discussed the need for getting the background information on the technology that was developed during the DEP approval process, and would like to see what information is readily available to the applicant or the engineer. The Board requested that the Coop address the items listed in Ball's review letter. The Board will await the submission of additional information from the Village Coop.
- 6.) Received from Deanna Allen, **51 Montague Road**, Well Permit Application and check #1060, dated 5/6/08, for \$75.00. Dauchy signed the permit with the condition that ConCom approval is needed before drilling occurs.
- 7.) Received from David Fredenburgh at Quabbin Analytical Labs, a letter explaining that his lab can run the Coliform bacteria test on soft serve ice cream.
- 8.) Received from the MA DPH Bureau of Communicable Disease Control, a confirmed report of Lyme Disease in a Leverett resident. No further follow-up is necessary.

- 9.) Received from Eternal Blessings Cremation Services of Guilford, VT, Cremation Certificate and Final Disposition Form for Nancy Kolakoski, disposed in East Leverett Cemetery on 4/12/08.
