- 5. 142 144 Montague Rd., David Biddle owner, septic system is in failure based on recent Title 5 Inspection. Pumping does not appear to be needed at this time there is no immediate risk to public health in Steve Ball's opinion. Steve Ball, HA will check system periodically for breakout with tenant's permission. The Board member Goscenski will draft a letter to Mr. Biddle identifying specific dates for the creation, approval and installation of a septic plan that reaches maximum feasible compliance with Leverett Local Regulations and send it via certified mail. The process should begin immediately and must be completed by June 30, 2009 to prevent the Board's pursuit of legal action. (See attached.) Propane heating system had not received a delivery as of 12/15/2008. Mr. Biddle will provide a receipt for the delivery as sufficient proof. The gas company is scheduled to make the next delivery on 12/22/08. The Board requires that a letter stating that the delivery person is a licensed inspector and that the system is functioning properly will be sent to the Board.
