[1] This project has been submitted as an Ecological Restoration Limited Project. The commission needs to review 310 CMR 10.11, 310 CMR 10.12 and 310 CMR 10.53(4)(e)5. as well as the included Appendix A. Please note that on Section B.2. of the narrative it references 310 CMR 10.24. That section references coastal wetlands, not inland.

[2] As the commission is aware, the use of a hydrorake can act as a dredge activity. The applicant shall submit a graphical representation of the work limits associated with this activity and support the information in the NOI that a Section 401 dredge permit is not required. Removing any bottom material is considered dredging, it just does not need additional permitting as long as less than 100 cubic yards removed in total of the up to 4 acres where this work will occur. Because one is dredging a Great Pond, a Chapter 91 license is required. The NOI appears to state that the area near the dry hydrant will be dredged. The 2010 NOI file number comments for 200-0166 noted that a Chapter 91 license was required but no application was submitted. Please ensure it is done for this project. Please provide more data for the dredging near the dry hydrant, both existing bottom contours and proposed contours.

[3] Any future NOI submitted for a drawdown over 3 feet will need to be reviewed by Mass Fish and Game as over 3 feet does not comply with the Drawdown Performance Standards or the GEIR.


