1. Received from Cooley Dickinson Hospital notification of a dog bite at **61 Cave Hill Road**. Clerk forward notification to Dr. Michael Katz at Hampshire Veterinary Clinic.
2. Received Bacteriological Report from Quabbin Analytical dated 6/2/2011 for Leverett Co-op. Absent of Coliform
3. Received from **Alan Weiss, MS** of Cold Spring Environmental Title 5 Inspection Report dated 5/26/2011 for **75 Amherst Road**, owner, **Nadia Margolis**. System failed. Received from Nadia Margolis check #6127, dated 6/7/2011 for \$600.00. (\$150.00 title 5, \$150.00 soil evaluation, \$300.00 DSCP Application. Soil Evaluation and Design yet to be done.
4. **Mike DeRosa**, present, Director of Summer Arts and Recreation Program at Leverett Elementary School. **DeRosa** is seeking a 1-year variance to State Regulation 105CMR 430.103 Section B. The 1-year variance is to hire a qualified lifeguard and to see if **DeRosa's** own qualification is adequate. **Steve Ball, Health Agent (HA)** supports this variance. **DeRosa** gave the Board a letter of explanation and relevant State Regulations. (See attached) **Fair** moved to grant a variance of State Regulation 105CMR430.103 Section B. **Hillman** seconded. The Board of Health feels that **DeRosa's** own Cold Water Rescue Certification beat R1 of State Regulation. Issued Permit #11-04. **Signed by Zipkowitz**.
5. **Carol Heim**, present, owner **13 Amherst Road**. She was seeking the Boards opinion on Filtration systems. The results of a recent water test showed high levels of iron and manganese. Use of drywell for disposal of back flush from a filter system was discussed. No decisions were made.
6. Received copy of latest map of watershed @ Atkins Reservoir in Amherst. The Board noted that if we get an application for DSCP in the watershed area we make sure we comply with those regulations regarding the watershed area. The only area in Leverett within the PWS watershed is a small portion of Pratt Corner Road.
7. Received application to conduct a Recreational Camp from Khalsa Camp, dated 6/27/2011, owners Jai Fuller and Siri Om Fuller. Application approved. Issued Permit# 11-05. Signed by **Zipkowitz**.
8. **Hillman** will continue to work on Emergency Preparedness brochure.
