# FROM THE SELECT BOARD

#### Town Hall preservation

The renovation and repair of the Town Hall exterior is well under way. Primed siding is being installed on the north side of the hall with rotted sills being replaced as needed. The Select Board has received bids for the painting of the building and so far all the work is well within the budget provided by Community Preservation Committee. Thanks to John Kuczek, Greg Woodard, Julie Shively and Margie McGinnis for all the time and expertise put into this project.

#### Energy Upgrades

The Town has continued to implement energy upgrades in Town Hall. Work includes the installation of new furnaces, new duct work to carry heat to all the offices and insulation. We hope to have the job complete soon.

#### School Roof and Window Replacement

The window replacement project has now been scheduled for next summer due to the long delivery time of the windows and the asbestos remediation required as a part of the removal of the old windows. The slate roof repair project has been bid twice with the few bidders not meeting the minimum experience requirements or not being able to secure bonding. The Board is requesting approval from the State to rebid the project this fall. Many experienced contractors have not bid on our project because of commitments to repair buildings damaged by the tornado this summer.

#### Weed Harvesting at the Pond

The weed harvesting project at the boat access on Depot Road has been completed. Grass is well established and the access way restored. A picnic table has been installed. Enjoy the wonderful view!

#### FEMA Grant for Water Tank

The Select Board also has submitted an application for funding through FEMA for a large underground water storage tank to be installed in the school playground. This tank would provide a permanent and accessible water supply to fight fires in town. The initial response from FEMA has not been positive. Meetings continue as the submitted projects are evaluated.

#### Cave Hill Road and the Sawmill Pond Project

During the summer the sawmill dam was breached lowering the pond to stream flow. The town took the opportunity to remove the large sediment deposits that had accumulated in the pond and under the Cave Hill Road bridge. One of the two bays of the bridge was partially blocked and the overall volume of the pond was reduced by the material. It was also an opportunity to sand-blast and paint the steel support beams under the bridge. This was one of the bridges that had not been repainted over the past 5 years. The work was completed just before the hurricane and subsequent tropical storm passed through. The scaffolding remained in place, making it through the storm and high water. Thanks to Will Stratford and the Highway Department for adding this project to their summer project schedule. Thanks to Dave Powicki and the Conservation Commission for working with us to get through the permits and turtle survey required. The removal of built-up material under and around this bridge will be necessary in the future in order to protect the structure from high water impacts, to maintain the function of the fire hydrant (one of two in town that can supply sufficient water to fight a fire) and to protect the town's investment in the sawmill building and dam.

#### Town Water to Leverett

The Board has held discussions with the Town of Amherst looking into the possibility of installing a water main from North Amherst to the homes that have been impacted by the plume from the old landfill in the Teawaddle Road area. These talks are in the preliminary stage. A letter has been sent to the Amherst Select Board to gain initial approval and commitment for the connection before the town hires an engineering firm to prepare plans, permits, and specifications for the project. Investigation into available funding sources has begun. Funding for the design may be requested as soon as fall town meeting this October.

**Noise Complaints** The State Police have responded to complaints of large late night noisy parties in town. Written complaints should be made to the Select Board to utilize the town's noise by-law approved last year. The Board will

contact the <u>owner of the property</u>. Further complaints will result in the <u>owner of the property</u> being fined on an increasing scale. Please be respectful of your neighbors. *Rich Brazeau, for the Select Board* 

## **Community Preservation Committee**

DO YOU HAVE A PROJECT THAT REQUIRES FUNDING?

The CPC has funds available and is seeking proposals for the next funding cycle. If you have a proposal for open space preservation, historic preservation, community housing or recreation, please consider applying. Application forms are available from the Town Hall or may be downloaded from the Leverett Town Hall website at <u>http://leverett.ma.us/</u>. Our application deadline is **December 1**.

To encourage you to think of a project you might want to propose, we want to remind you about some of the projects that have been accomplished in our community with our Community Preservation Act funds. Details of these projects are available at Town Hall.

Open Space and Recreation funds have been used to purchase a number of parcels of land, for example, three parcels on Leverett Pond, formerly owned by Carlyle and Edith Field, David and Mary Field, and Phillip and Catherine Woodard. These include the Friendship Trail which goes along the shoreline from the channel inlet off Depot Road at the south end of the pond to Cider Mill Lane. Open space funds were also used to restore the weed choked inlet channel and improve public access to the pond.

Historic preservation funds have been used to restore the street side of the Leverett Crafts and Arts Building. You'll also notice work in progress to restore the Town Hall including new clapboards and fresh paint. In addition, research is underway to prepare documents for National Register Historic Districts for North Leverett, Moore's Corner, and East Leverett Centers, to join our Leverett Center Historic District.

Community Housing funds have been used to fund the Leverett Affordable Housing Trust. The Selectboard continues to work on a variety of ways for people to obtain affordable housing in Leverett.

#### We hope these examples will inspire you to propose Leverett's next great project!

The next CPC meeting is at 7:30 on Wednesday, October 12, 2011, at Town Hall when we will be glad to discuss proposals. ### **Council on Aging News**

**Flu Clinic** – Unfortunately, the Leverett Flu Clinic is in transition this year. Residents who have Medicare (or any insurance that covers the vaccine) are no longer eligible for the shots at our site due to changes in DPH policy. But next year, we are looking into a possible new and improved flu clinic in town for all. If so, we plan for the COA to continue to support a morning clinic for those over 60. Please read the "flu clinic" blurb elsewhere in this newsletter for more information.

<u>Volunteers Needed</u> - Plan a monthly movie program for a while, be a friendly visitor or caller, JOIN THE COA (we need your energy and interest!), call us to just talk about your concerns regarding those over 60 in Leverett and what you would like your COA to be doing.

**Part B Insurance and Medicare** - As you probably know if you have Medicare, open enrollment dates for changes to your Part B policy have changed to October 15<sup>th</sup> to December 7<sup>th</sup>. Instead of a talk, Lorraine York-Edberg, director of SHINE, will be scheduling half-hour appointments in town on November 1. Please call the COA to schedule a visit with her and we will send you a list of items to bring with you to make the meeting as productive as possible.

**Fuel Assistance Help** – Although the word is that there is less fuel assistance available this year, it is still worth applying if you fall within the income limits. I am available (and trained) to help with recertification applications and, starting November 1, to fill out new applications. Call the COA to make an appointment.

<u>Preventive Medical Exams</u> - Medicare now covers a long list of preventive exams as well as an annual "wellness exam." These exams range from an abdominal aortic aneurysm to diabetes screening. You can get a checklist of these exams to discuss with your doctor by calling 1-800-Medicare and asking about preventive services and the checklist.

<u>Home Weatherization Help</u> - Mass Save can provide 75% funding to insulate or weatherize your home. For consumers over age 60, FCHCC (Home Care) might be able to match the Mass Save money by paying the remaining 25%. Call Mass Save at 866-527-7283 to schedule an audit. When you receive your contract, please contact Home Care's Benefits Counseling Program at 413-773-5555. **Special Thanks** to everyone at the Safety Complex for sharing your room with the mealsite and the yoga class while Town Hall is under renovation.

#### FLU CLINIC UPDATE

In the past, Leverett has received free vaccines from the Department of Public Health. Mary Jo Korfhage, BSN, and Sandy Rogers,RN, administered the shots as volunteers and the Council on Aging helped run the clinic, mostly for those over 60 or with chronic conditions. Last year, stimulus money helped to pay for the vaccine. This year, without that money, the DPH has reduced the number of vaccine available for free and has decided that only uninsured or underinsured people receive this freeto-the-town vaccine. This policy is a big difference from past years when seniors with Medicare and those with chronic conditions were still able to get the vaccine at this kind of flu clinic. Another big difference is that now children are the priority recipients of the vaccine, not seniors.

However, it appears that there is plenty of the vaccine around. If you have insurance, including Medicare, it is suggested that you get the vaccine where you can, as long as you are not paying out of pocket for anything. You should be asked to sign a waiver allowing the doctor (or whomever) to bill your insurance company or Medicare for both the vaccine and the administration of the vaccine.

If you or someone you know is uninsured or underinsured and would like to receive one of the flu shots reserved for Leverett, please contact Mary Jo Korfhage at 548-9616. Depending on the response to this request, we will decide how to proceed.

Looking ahead to next year, we hope to bring much better news. We hope to be working with the Leverett Board of Health to bring you a flu clinic again, everyone invited, but instead of counting on the free shots that DPH is willing to give us, we are looking into paying for the vaccine and then roster billing insurance companies. The reimbursement from the insurance companies should be more than enough to make the flu clinic a self-sustaining entity, especially with volunteer administration of the shot and of the paperwork.

#### THE TOWN OF LEVERETT IS A MEMBER OF THE CONNECT-CTY SYSTEM

(Connect-CTY a Service to Enhance Emergency Outreach and Communication)

The *Connect-CTY* service allows emergency and town officials to send and track personalized voice messages to residents in just minutes through a single phone call. The service requires no additional hardware; it can be used from any computer with internet access or telephone. This ensures that emergency officials as well as town officials can send out vital messages, such as severe weather, dam failure, or public health warnings as well as school closing and community outreach.

It is important that we have accurate telephone and e-mail information; if your information has changed or if you're new to town you can log onto to the town's website <u>www.leverett.ma.us</u>, on the left side click **Connect-CTY** then click **SIGNUP NOW** to enter your information. If you do not have internet access or are having trouble entering your information, please call 413-548-1022 X4 and leave your information and we will enter it manually. #### FROM THE ASSESSORS

The Board of Assessors is in the final stages of completing the triennial revaluation of real estate assessments. Massachusetts state law requires all real estate to be assessed at full market value, and further requires all cities and towns to bring their real estate valuations into line with the actual real estate market. In order to meet this requirement, we have analyzed all property sales in Leverett from July 2009 through June 2011, and adjusted our underlying assessment tables. The end result is a decrease, on average, of approximately 5% town wide. Due to the variations in properties, the change in your assessment may be more or less than this figure.

Although we have not received approval from the state, we are making the proposed new assessments available for review at the Town Hall and Leverett Library. They will also be posted on the town's website (leverett.ma.us). These new assessed values will be used to determine the tax rate and thus individual tax bills for Fiscal Year 2012 [FY12] covering the period of July 1, 2011 to June 30, 2012.

Once the Massachusetts Department of Revenue grants preliminary approval, the assessors will be holding informal meetings where you may ask questions and discuss your assessment. These meetings usually are held on Monday and Thursday afternoons and evenings, and by appointment.

Following the public comment period, we will submit the valuations, with any revisions, to the DOR for final approval. Once the values are approved, we will proceed to set the tax rate and mail the tax bills. The FY12 tax rate for Leverett cannot be determined until these new values are approved. As always, you have 30 days following the mailing of the tax bill to file for an abatement.

#### **Leverett Family Museum**

The Camp Anderson exhibit will soon be on its way to a permanent home at Pine Brook Camp (formerly Camp Anderson) in Shutesbury. The *Life in Leverett 100 Years Ago* show (highlighting the lives of Fanny and Israel Taylor) will continue until mid-December, when we close for the winter. It will be expanded by adding a few examples of what life was like 150 or 200 years ago.

Paul Marchant, of Scituate, MA, has donated a copy of the 1856 and 1857 diaries of Ely O. Dickinson, who lived at 257 Montague Road during the mid- and late-1800's. Paul is the great-great-grandson of Ely. They include family pictures, diary pages, and a newspaper article written by Agnes Dods of Leverett about Ely's Civil War diaries, which Paul also has. Another view of life hereabouts can be seen by examining a daybook (ledger) that was used at a store located at 148 Shutesbury Road in 1810 and 1811. It was owned by Jonathan and Harvey Conant and by a unknown member of the Field family, who has so far escaped identification. We're still working on that one! The book has lists of the items sold with prices listed, as well as the customer's name. Interesting reading!! A smaller edition of this book was found by Stuart Olson, who now lives at #148, but it is in poor condition and must be handled with care. It was used in 1817 and 1818, but has the same handwriting and names contained in the older book.

We are beginning work on a project of making a large map of Leverett, with notations on it, identifying the working mills that were located on the Sawmill River and Roaring Brook in the 1800s. Lots of goodies!!

#### FROM THE TOWN COLLECTOR

FISCAL 2012 PROPERTY TAX BILLS have NOT been mailed. They should be in the mail by mid-November and due within 30 days. VOLUNTARY PAYMENTS (any amount) ARE VERY MUCH APPRECIATED as we have a serious cash flow problem this time of the year. Town bills still need to be paid. MANY THANKS TO ALL WHO HAVE ALREADY SENT IN PAYMENT!

Your tax bill(s) will show the amount of real estate and/or personal property tax you owe for fiscal year 2012 (July 1, 2011 through June 30, 2012) based on assessments as of January 1, 2011). Please check the bills carefully and report any errors or changes to the Assessors' Office (548-4945). By law, the name of the owner of record on January 1, 2011 must appear on the bill, so if you purchased the property after January 1, you do not need to notify us you now own the property. Total amount owed can be paid in one or two payments (bills \$200 or less must be paid in full). Payments received after the due date will be assessed 14% interest FROM DATE OF MAILING until the date received (yes, that means "one day late, 30 days interest"; this is still the law for semi-annual payments). You will not receive a bill for the balance due; it will be added to your second payment due May 1, 2012. If you plan to pay your bill late, contact the Collector's Office for the total amount owed. If you have an escrow account, your bank will be notified of the amount due, so keep the bill for your records.

On March 18, 2002, Leverett voters accepted CH44B **COMMUNITY PRESERVATION ACT (CPA)** and approved a 3% property tax surcharge (\$100,000 assessed value is exempt). The amount of the surcharge is required to be listed separately; however, it is part of the tax bill and subject to the same interest and penalty charges for late payment. <u>Low or moderate-income households may qualify for exemption from this surcharge</u>. Request application or additional information from the Assessors' Office 548-4945 or <u>assessors@leverett.ma.us</u>

<u>Once bills are mailed</u>, you will have 30 days to pay without penalty, but please remember *it is always the responsibility of the taxpayer to be sure payment is received on time*, *regardless of when or IF a bill is received*. If you own property and didn't get a bill, contact the Collector's office. Allow at least 3-4 days when mailing payment. DO NOT MAIL THE BILL ON THE DUE DATE, as a postmark is not considered timely payment. If you are making a "Due-Date payment," bring it directly to the Collector's Office (remember, don't mail it at the Leverett PO since ALL mail goes to Springfield first and will be received late). Better still, become part of the paperless society. Sign up for DIRECT PAYMENT and we will automatically debit your account on the due date (or every month): no check, no envelope, no stamp, no trip to the post office or town hall, and no late fee because you forgot the due date! You can also pay your bill online at leverett.ma.us (you initiate a debit to your bank account – no charge for this method; however, there is a charge for Mastercard & Discover payments; Visa & American Express not accepted), or drop off payment in box at back entrance of Town Hall. Office hours: Mon; Tu, Th, Sat: 2:30 – 8:30 pm; (HOURS MAY VARY so call ahead 548-9666; if you leave a message, I will return your call); e-mail: treasurercollector@leverett.ma.us. If you need a receipt, please come during office hours or leave a stamped, self-addressed envelope in the Collector's mailbox. Please do not interrupt other Town Hall staff for tax payments/receipts.

THANK YOU FOR YOUR PROMPT PAYMENT.

**VOLUNTARY CHECK OFF:** In April 2000, Leverett voters accepted the provisions of Ch60, sections 3C and 3D allowing the town to designate a place on the tax bill whereby a taxpayer can make donations to the Scholarship Fund and/or Tax Relief Fund (aid to homeowners age 60 and over or disabled persons (any age) of low income for the purpose of defraying real estate taxes). We appreciate your continued support of these programs. Donations can either be made to the Fund or you can request your donation be applied to a specific tax bill. The Tax Relief Committee distributes amounts depending on availability of funds and number of applications received. If you think you may qualify for tax relief, call or email the Collector to request an application

**RESIDENTS OVER 65**, widows and widowers, disabled veterans, and the blind *may* be eligible for a reduction in their taxes. Contact the Assessors Office at 548-4945 for more information.

PLEASE NOTE: As voted at Annual Town Meeting, effective January 1, 2010, the DEMAND FEE for late payment INCREASED from \$5 to \$10. This is in recognition of the additional time and resources necessary to process late payments and applies to Real Estate, Personal Property, and Excise bills. <u>PLEASE</u> make every effort to pay your bill by the due date since the collector is not authorized to waive or reduce this fee regardless of all the good reasons you have for <u>not</u> paying on time: didn't get a bill, out of town, thought it was due the day after it was really due, wrote out the check but forgot to mail it, *mailed* it on the due date (payment must be *received* by the due date), the Town Hall was closed, etc, etc. If remembering due dates is not your forte, sign up for direct pay and NEVER pay another late fee. Or for all you lucky residents with DSL, pay online and your account is immediately credited. Still struggling with dial up? -- call the office and we will process payment for you. We hope the fee increase will provide incentive to pay early rather than just produce additional revenue to meet town expenses.

#### From the Peace Committee

Last Spring, Town Meeting authorized the Peace Committee to continue its work and to define and refine its mission. The committee has continued to meet over the summer. Our real task now to is facilitate Leverett people to articulate their major concerns and purposes as regards sustainability, social justice, and peace, and then to help us connect with similar people and small groups in other communities -- both in New England and then further afield. We are planning programs and dialogues to advance critical analysis of the American society and economy as it impacts us locally, and then to move to locally appropriate actions.

Our first program on the subject of race relations and the legacy of slavery, was presented by Tim Bullock, last year's winner of the Martin Luther King, Jr. award from Greenfield Community College for his work in advancing the cause of race relations. We expect to bring other speakers, and are trying to bring Rep. John Olver.

Penny Gill, political scientist and former Dean of the College at Mt. Holyoke, who drew an audience of 150, has agreed to return to Leverett to help us think critically about our situation here in the world, the United States and Leverett, and to envision and articulate the peace committee's work. People who are interested in being with others to do creative writing on public issues may talk with Alice Scheffey who has brought together a writer's group. Sarah Pirtle will be back in Leverett in the winter to repeat her Vacation Peace Project with the children. Court Dorsey will create a performance piece for Leverett meant to inspire us with a vision of the need for change, the change that is already happening, and a future worth working for.

The committee's central goal for this coming year is to reach out to all segments of the Leverett community in order to understand the varying points of view, and gather the wisdom of the town as regards the promise and the problems of Leverett and the impact of world and national realities on our lives here. Pat Fiero and Jann Rosemerta are leading this effort.

#### A GRAVE SITUATION HAS ARISEN!

There are a number of ways to record history. Leverett has close to a dozen places where it is recorded, from one end of town to the other. Some are visible, some not. Some are small; some not. Some are newer than others. Some have recorded a great deal of history, others not so much. Some are in good condition, some not so good. And we'll bet that most of you have seen one recently. Have you guessed the answer?

The two Leverett Cemetery Associations are facing a GRAVE SITUATION. Many of the stones that are recording the history of our town are sadly in need of T.L.C. A group of concerned citizens has been meeting for the last several months in an effort to correct the situation. This group includes, Charlotte and John Abbott. Don Robinson, David Glazier, Will and Lisa Stratford. A conservator, Ta Mara Conde of New Salem has met with the group.

She has agreed to assist the group in assessing the condition of the stones (specifically the Moore's Corner Cemetery on Rattlesnake Gutter Road). She also will help with the process of applying for C.P.A. funds, which would be available next summer. She is holding a workshop on October 15th (at the cemetery), from 9 a.m. till 3 p.m. to instruct volunteers in making simple repairs. These will include straightening stones, cleaning, repairing and making bases and also simple repairs to broken stones. It is hoped that these volunteers will pass the new skills on to others, as the project continues. The harder work will be carried out by Ta Mara, provided she is awarded the grant by the C.P.A. committee.

Actually, both Associations have been very pleased with the discussions we have had with her and we are looking forward to working with her as long as this GRAVE SITUATION continues.
