PROJECT NARRATIVE

- 1. Goals and description:
 - A. Project goals. The goal of the project is to provide two public outdoor pickleball courts in Leverett. The courts would provide a recreational space for people of all ages to gather and participate in a popular and ever-growing sport promoting the health and happiness of all Leverett residents.

- B. Description of project activities and outcomes and the property involved and its proposed use. Construct two dedicated pickleball courts, at least one of which would be ADA-compliant, surrounded by fencing, with noise-mitigation measures in place. The courts would connect to the library's pocket park via an ADA-compliant path. The courts would be free and open to the public during set hours. The primary use would be pickleball; however, the courts could also be used for badminton (with different, portable nets).
- C. **Indication of how the project is eligible for CPA funding.** The project would develop a new recreational space, which is an eligible use of the funds.
- D. **Description of the project applicant and any project partners.** The primary project applicant is the ad hoc committee of Pickleball for All of Leverett (PAL), supported by the Leverett Recreation Committee and the Rattlesnake Gutter Trust. Support from the Leverett Public Library and Leverett Elementary School is anticipated.
- 2. Community need: Indicate what community need(s) the project will address and how these are consistent with Town policy and plans. Describe the ways that the project will benefit the town.

In recent years, pickleball has rapidly become very popular in towns all around the U.S., and Leverett is no exception. For the last three years, the Leverett Elementary School (LES) has kindly allowed the introduction of pickleball to the community. Now, pickleball-crazed residents organize games on Saturday mornings and Sunday and Monday afternoons and evenings, from November through May. Slots fill up fast, necessitating caps on the number of slots per week any one player can sign up for. The number of people requesting to be on the mailing list for sign-ups is 104—over 6% of the Town's population.

Until pickleball came along, Leverett residents had few places to meet and connect other than the transfer station. Some players report that they have made friendships and connections they would not have otherwise; others report reconnecting with friends and neighbors—all with the added benefits of fun and fitness.

Pickleball is easy to learn, and the pickleball scene at LES is intergenerational. Games commonly include both teenagers and retirees. Although only four people can play on the gym's court at once, each time slot on Sunday and Monday gets six names on the sign-up sheet, and players take turns rotating on and off the court between games. This allows more people a chance to play, and also allows each player who is resting

between games a chance to chat with the other players—thus facilitating a sense of community. People often arrive early and leave late, perhaps so they don't miss a minute of allotted playing time, or perhaps just to enjoy the social scene. On Saturday mornings from 9 to 12, there are no sign-ups: People can just drop in and play. Often, there are more players off the court than on, necessitating a waiting-list system and more chatting.

Clearly, there is a great deal of interest in pickleball among Leverett residents, but there are not enough courts or court time to go around. The addition of outdoor courts would allow even more residents to participate in this popular sport, and to do so year-round.

Our goal is to ensure that the pickleball courts support and are considerate of our community members. To that end, we plan to close the courts during outdoor library events, such as music performances, and regulate the hours of operation to avoid early morning and later evening hours.

The Town of Leverett is the landholder of the property. The Town Highway Department maintains the library grounds and playing fields and has committed to mowing around the prospective courts. Players will be responsible for keeping the courts clear of leaves and other debris. The courts will come with a warranty. We anticipate using fundraising efforts to cover the costs of long-term maintenance, including periodic court resurfacing (approximately every six to eight years), net replacement, and other repairs.

We will measure the project's success by the number of people who use the courts to play pickleball. The courts will add diversity to the kinds of recreation available in Leverett.




3. Project Timeline.
