GREETINGS:

In the name of the Commonwealth, you are hereby directed to notify and warn the inhabitants of Leverett, qualified to vote in the Town affairs, to meet in the **LEVERETT ELEMENTARY SCHOOL GYMNASIUM** at said Leverett, on **TUESDAY, OCTOBER 3, 2006** at 7:00 in the **EVENING** (7:00 p.m.) then and there to act on the following articles, namely:

Article One: To see if the Town will vote to reduce the FY 2007 appropriation for the Elementary School (Account # 300) by the sum of \$30,000, or take any other action relative thereto.

Article Two: To see if the Town will vote to raise and appropriate additional sums of money for the FY 2007 operating budget, as follows, or take any other action relative thereto:

Article Four: To see if the Town will vote to transfer a sum of money from the Board of Health Legal account established by Article One of the December 7, 2005 Special Town Meeting to complete a water issues study, or take any other action relative thereto.

Article Five: To see if the Town will vote to transfer a sum of money from the Town Hall Roof account established by Article Eight of the April 29, 2006 Annual Town Meeting to replace the North Leverett Fire Station roof, or take any other action relative thereto.

Article Six: To see if the town will vote to transfer the sum of \$548.16 from the Road Machinery Fund to the Highway Equipment Account, or take any action relative thereto.

Article Seven: To see if the Town will vote to transfer the sum of \$60,000 from the Stabilization Account to offset the tax rate, or take any action relative thereto.

And you are directed to serve this warrant by posting up copies thereof on the post office and in the Town Hall and Congregational Church at Leverett, also the Baptist Church at North Leverett and the Village Co-op at Moores Corner, fourteen days at least before the day of said meeting.
