



# WARRANT

Town of Leverett  
Special Town Meeting

To One of the Constables of Leverett:  
Greetings:

In the name of the Commonwealth, you are hereby directed to notify and warn the inhabitants of Leverett, qualified to vote in Town affairs, to meet in the **Elementary School auditorium, on Tuesday the 19th of November 2024, at 7:00 in the evening (7:00 p.m.)**, then and there to act on the following articles, namely:

**Article One:** To see if the town will vote to transfer a sum of \$90,000 from available funds for the purchase of a new highway department truck, or take any action relative thereto.

**Article Two:** To see if the Town will vote to appropriate \$8,508 from the Community Preservation Fund Balance reserved for Open Space/Recreation to provide funds to the Friends of the North Leverett Sawmill ("FONLS") to pay for Grave's ironworks research, trail and bridge work done on 2.0 acres of land owned by the Town of Leverett and contiguous to Heritage Park trails on 2.6 acres of FONLS land adjacent to the N. Leverett Sawmill, or to take any action relative thereto.

**Article Three:** To see if the Town will vote to transfer the sum of \$114,900, from the Community Preservation Fund Balance reserved for Affordable Housing to the Leverett Affordable Housing Trust, or to take any action relative thereto.

**Article Four:** To see if the Town will vote to accept, for the boards and committees listed below which may hold adjudicatory hearings in Leverett, the provisions of MGL Chapter 39, section 23D, which provides that a member of a Board, Committee or Commission holding an adjudicatory hearing shall not be disqualified from voting in the matter solely due to the member's absence from one session of such hearing, provided that certain conditions as established by said statute are met, or take any action relative thereto.

Boards to be included are: the Assessors, the Conservation Commission, the Community Preservation Committee, the Cultural Council, the Board of Health, the Historical Commission, the Library Trustees, the Personnel Board, the Planning Board, the School Committee, the Selectboard, the Tax Relief Committee, and the Zoning Board of Appeals.

And you are hereby directed to serve this Warrant by posting up attested copies thereof on the Post Office, in the Town Hall and Congregational Church at Leverett, the Baptist Church at North Leverett and the Village Co-op at Moores Corner, fourteen days at least before the day of said meeting.
